### **MOJO POSSE BAND IS TO BE PAID AS FOLLOWS:**

A NON-REFUNDABLE deposit payment of \$\_\_\_\_\_ is due on signing payable to Jeff Gray.

Balance due at the end of the engagement is payable to Jeff Gray.

PURCHASER forfeits deposit to Mojo Posse Band in the event that the PURCHASER cancels the engagement for any reason.

PURCHASER will pay a minimum of 50% for any event cancellation or early termination. Cancellations and terminations include but are not limited to: outdoor event issues, bad weather, bad power and/or loss of power, municipal and civil disturbance complaints, etc.

### **ADDITIONAL PROVISIONS:**

Mojo Posse Band will provide their own Soundcraft and EV Sound System unless otherwise specified. Mojo Posse Band members may vary by time, date and venue.

PURCHASER shall provide at a minimum of (2) two 120 Volt 20 Amp grounded circuits of electrical power within 10 feet of staging area. (Extension cords must be pre-approved by Mojo Posse Band.)

PURCHASER is responsible for Staging and Lighting if needed.

PURCHASER is responsible for actions of all guests. Neither the Mojo Posse Band nor the individual performers shall be held liable for injuries and/or damages incurred by unauthorized persons on or around staging area. PURCHASER shall assume responsibility for damages to performer's equipment as a result of actions of all guests.
